<b>Placement Fee Per Student</b> (non-refundable)	\$250.00 + GST

<b>Short Notice Application Fee</b>	\$50.00 + GST

A student application submitted with less than 2 weeks (14 calendar days) from the arrival date is applicable for an additional charge.

Families are chosen to facilitate a “good match” between Student and Family. If the student has valid reasons and is not happy with their host family, Liane's Vancouver Homestay will locate a new host family for the student at no additional charge. This will be done one time only.

**NOTE:** If the student requests a third new host family a second placement fee will be charged.
